

UK – COTTON ON KIDS – WIN A WARDROBE COMPETITION

Terms and Conditions

- 2) Entry is open to all residents in United Kingdom. Entrants must be over the age of eighteen (18) to enter. It is the responsibility of the entrant to ensure they have such consent before participating. The Promoter may request proof of parental or guardian consent.
