

Cotton On X Destination NSW Promotion

Terms and Conditions

- The promoter of this promotion is Cotton On Australia Pty Ltd ("the Promoter") (ACN 634 090 083) of 14 Shepherd Court, North Geelong, Victoria 3215.
- Entry is free and open to individuals aged 18+ in Australia. Employees of the Promoter and their immediate families and the suppliers and agencies associated with this competition are ineligible to enter.
- 3. This competition commences at 9.00am AEST on 30th September 2020 and ends at 11.59pm AEST on 11th October 2020 ("Competition Period"). Entrants may enter only once. Late, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected responses will be deemed invalid. Entrants can only enter in their own name.
- 4. To enter this competition entrants must, during the Competition Period, submit on the Cotton On competition entry page, on the Cotton On website:
 - Tell us in 25 words or less why they want to explore our Aussie backyard;
 and
 - b. Their first and last name, email address, closest capital city and age.

Completing the above step constitutes a valid "Entry".

By entering this competition entrants agree to become part of Destination New South Wales' marketing database and the Promoter's marketing database and loyalty program Cotton On & Co Perks, from which they can 'opt out' of once they commence receiving email communication.

- 5. Each Submission will be reviewed and judged by a panel of the Promoter's marketing and communications personnel ("Panel"). The Panel will judge each response according to how relevant, creative and inspiring it is. All decisions of the Panel are final and no discussions or correspondence will be entered into.
- 6. There will be one (1) major prize winner and that will be the person that provided the most creative answer.
- 7. There will be five (5) runners up prize winners and they will be the people with the second, third, fourth, fifth and sixth most creative answers.
- 8. The winning entries will be picked at random from all the Entries ("the Draw") 10.00am 13th October 2020 at the Promoter's address.
- 9. The winner and runners-up will be notified via the email, to the email address they submitted as part of their Entry. The winner and runners-up are required to respond to the Promoter with their postal address and phone number. The winner must also



notify the Promoter of the postal address of the friend they wish to take on the trip. By providing this information the winner warrants that they have their friend's permission to share this information with the Promoter.

The New Winner or New Runner-Up must respond to the Promoter's message as soon as possible, at the latest being three (3) months after being notified 12th April 2021, or the Promoter may deem that the New Winner or New Runner-Up is ineligible to receive a prize.
